## Preparation

## **Directions for Use**

If necessary, wash dog to remove dirt and grease. Long-haired animals can be clipped prior to treatment if required. Prepare the dog wash by adding the appropriate amount of Taktic® to the required volume of clean warm water, stirring to ensure complete mixing. Prepare only the required amount of wash for each individual treatment. Diluted fouled wash becomes unstable upon prolonged standing. Sufficient solution should be prepared to allow complete immersion of the dog's paws and to enable complete wetting of the animal. Stand the dog in a basin or sink and pour Taktic®wash over the animal, gently working into the skin and hair with a soft brush or sponge to ensure that the dog is thoroughly wetted to the skin in all areas.
