Nobilis Corvac is an inactivated trivalent vaccine containing the Avibacterium paragallinarum strains 083 (serotype A), Spross (serotype B) and H18 (serotype C) incorporated in a water-in-oil emulsion.

Composition: Each dose of 0.5 ml of vaccine contains, -at least 1 CPD₇₀ each of the serotype A, B and C of Avibacterium paragallinarum, inactivated by thiomersal and suspended in the aqueous phase of a water-in-oil emulsion.

Indications:

Vaccination against Avibacterium paragallingrum infections in chickens.

Vaccination Scheme:

Subcutaneous injection of 0.5 ml of vaccine in layers and breeders from 5 till 10 weeks old and a revaccination a few weeks before the onset of egg production. Interval between vaccinations at least 6 weeks.

Dose and administration:

Inject 0.5 ml per bird subcutaneously in the lower part of the neck.

Compatibility:

s have been found when Nobilis Corvac was applied simultaneously with Intervet's inactivated vaccine No i teraction Nobilis IB+G+ND

Vaccination Reaction:

In healthy animals no clinical reactions to vaccination will be observed. Slight swelling at the site of injection for some weeks after vaccination is occasionally observed.

To the user

This product contains mineral oil. Accidental injection/ self injection may result in severe pain and swelling, particularly if injected into a joint or finger, and in rare cases could result in the loss of the affected finger if prompt medical attention is not given. If you are accidentally injected with this product, seek prompt medical advice even i only a very small amount is injected and take the package leaflet with you.

To the physician:

This product contains mineral oil. Even if small amount has been injected, accidental injection with this product can cause intense swelling, which may, for example, result in ischaemic necrosis and even the loss of digit. Expert, Prompt, surgical attention is required and may necessitate early incision and irrigation of the injected area, especially where there is involvement of finger pulp or tendon.

No particular symptoms at double dose.
