# PROPERTIES :

# FREQUENCY OF TREATMENTS RECOMMENDED:

Mites: Two treatments at 8 days interval.

Ticks: First two treatments at 15 days interval and then treat depending on reinfestation.

Lice & Flies : As per requirement.

### SPRAY .

Make a solution by adding a small quantity of water (for example 1 lit.) to the required quantity of butox®

Stir thoroughly and then fill it up with the required quantity of water to make the final spray solution.

Use a minimum quantity of 3 to 5 litres of spray solution per adult animal.

Ensure thorough coverage, particularly in the preferred sites of parasites.

# PLUNGE DIPS:

a) Charging: According to the charging dosage, make a solution of the necessary quantity of butox<sup>®</sup>. Distribute the solution along with length of the dip, then stir for 10 minutes to obtain a perfect emulsion.

b) Topping up: After animals pass through, and as soon as the dip volume falls below 10% of its initial volume, topping up to be done by adding necessary quantity of water and butox.

# **GENERAL INSTRUCTIONS:**

Stir thoroughly before animals pass through the dip. Ensure that 20 of the first animals are redipped during the course of dipping.

Ensure that the animals are neither tired nor thirsty before treatment. Do not treat animals during warm hours.

# STORAGE:

Store protected from light.

# PRECAUTIONS:

Keep the product out of reach of pets and away from food stuffs. Do not eat, drink or smoke during treatment. Wash hands thoroughly with soap and cold water. Do not pour unused solution into rivers or ponds. If swallowed, do not induce vomiting. If large quantities have been swallowed, gastric lavage is advised. Avoid aspiration. Call a medical practitioner who will treat symptomatically.
