DOSE AND ADMINISTRATION
Depending upon size and weight

Cattle, Horse: 5-20 ml by intravenous injection.

Pias: 5-20 ml by intravenous injection

Sheep, goats: 1-3 ml by introvenous injection According to the size and weight of the animal. Dosage should be repeated at short intervals (of 1-3 days) until recovery is evident.

**Dogs, Cats:** 1 - 3 ml by subcutaneous, intramuscular or intravenous injection. For chronic conditions, 5-10 subcutaneous or intramuscular injections should be given at 48 hours interval with the dose rate of 1-2 ml.

Storage: Store below 25°C. AVOID FREEZING Presentation: Vials of 10 ml, 30 ml & 100 ml Withdrawal Period: Meat - 0 days, Milk - 0 days
